The Board of Supervisors of the County of San Benito ordains as follows:

- **Section 1.** Subdivision (A) of Section 5.01.259 ("Fee Payment") of Article VII ("Traffic Impact Fees") of Title 5 ("Finance") shall be amended to read as follows:
- (A) Prior to issuance of a building permit, an applicant shall pay to the building department the fees prescribed by resolution or shall present written evidence that the provisions of this article have otherwise been satisfied with respect to the development for which permits are sought.
- **Section 2.** Subdivision (A) of Section 5.01.291 ("Fee Payment") of Article VIII ("Fire Mitigation Fees") of Title 5 ("Finance") shall be amended to read as follows:
- (A) Prior to issuance of a building permit, the applicant for the building permit shall pay to the Director the fees prescribed by resolution, or shall present written evidence that the provisions of this article have otherwise been satisfied with respect to the development for which permits are sought and that the district concurs with this determination that the requirement has been satisfied.
- **Section 3.** Subdivision (A) of Section 5.01.320 ("Fee Payment") of Article IX ("Capital Improvements Impact Fees") of Title 5 ("Finance") shall be amended to read as follows:
- (A) Prior to issuance of a building permit, an applicant shall pay to the Building Department the fees prescribed by resolution or shall present written evidence that the provisions of this article have otherwise been satisfied with respect to the development for which permits are sought.

## **Section 4. General Provisions**

- A. Severability: If any sentence, subsection, clause, or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of the ordinance. The Board of Supervisors hereby declares that it would have enacted this ordinance and each section, subsection, sentences, clauses or phrases thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid or unconstitutional.
- B. Captions: The titles and headings to sections of this ordinance are not part of this ordinance and shall have no effect upon the construction or interpretation of any part hereof.

- C. Effective Date and Codification: Sections 1, 2 and 3 shall be codified in the San Benito County Code. The remaining sections shall not be codified. This ordinance shall take effect and be in full force and effect thirty (30) days after its final passage.
- D. Publication: Within ten (10) days after its adoption, this ordinance shall be published pursuant to California Government Code 6061 in its entirety in a newspaper of general circulation which is printed, published and circulated within San Benito County, or a summary or display ad may be published as allowed by the Government Code.
