NO. 2014-27, ESTABLISHING A NEW GENERAL)
ASSISTANCE STANDARD OF AID, AND ADOPTING)
REVISED GENERAL ASSISTANCE PROGRAM)
POLICIES AND PROCEDURES)

WHEREAS, on April 1, 2014, the San Benito County Board of Supervisors adopted Resolution No. 2014-27, establishing a new General Assistance standard of aid and adopting General Assistance program policies and procedures for the administration of the General Assistance Program; and

WHEREAS, Welfare & Institutions Code §17000.5 permits the Board of Supervisors to annually adjust the standard of aid for General Assistance to reflect increases and decreases in the maximum aid level in the County under the CalWORKs program, commencing with 62% of the Federal Poverty Level effective 1991; and

WHEREAS, the current General Assistance standard of aid needs to be adjusted to correspond with CalWORKs aid adjustments; and

WHEREAS, there is a need to revise program policies and procedures to reflect the new standard of aid, additional program participation requirements, and clarify County and recipient roles and responsibilities in accordance with Welfare & Institutions Code §17000 et.seq.

NOW THEREFORE BE IT RESOLVED, Board Resolution No. 2014-27 is repealed as of July 26, 2016, and the San Benito County Board of Supervisors adopts as a new General Assistance standard of aid the amounts set forth in the General Assistance Maximum Aid Tables of the revised 2016 Policy and Procedure Handbook.

BE IT FURTHER RESOLVED, that the San Benito County General Assistance Policy and Procedure Handbook be revised as set forth in Exhibit "A," attached hereto and by this reference incorporated herein as if fully set forth, to accurately reflect the new General Assistance standard of aid and to clarify current program regulations made true by this resolution;
