Dear Lieutenant:

Section. 3.02 of our agreement reads as follows: "The June 2009 monthly base price will be adjusted on July 1, 2009 based on the following percentage:

The percentage increase of the Medical CPI for the San Francisco-Oakland Region from February of the past year to February of the current year. This percentage increase will also apply to the per diem charge described in section 3.03."

The Bureau of Labor Statistics no longer reports Medical CPI information for this area. The area is in the West Urban region; therefore, we will be requesting a modification to our existing contract to substitute the All Consumers - West Urban Region - Medical Care CPI index.

If the All Consumers - West Urban Region - Medical Care CPI index is used, the statistic for the fiscal year 2016-2017 starting July 1, 2016 is 3.71% (copy attached). The monthly payment will be adjusted on July 1, 2016 from \$81,477.72 to \$84,500.54 (\$81,477.72 times 1.0371 equals \$81,500.54). The per diem will be adjusted from \$4.13 to \$4.28 (\$4.13 times 1.0371 equals \$4.28).
