5 TITLE I MASTER SUBGRANT, YOUTH PROGRAM ALLOCATION FOR PROGRAM  
6 YEAR 2016-2017, APPROVING THE SUBGRANT AGREEMENT AND DELEGATING  
7 AUTHORITY TO SIGN THE SUBGRANT AGREEMENT AND OTHER DOCUMENTS  
8 RELATED TO RECEIPT OF THE SUBGRANT

9 WHEREAS, the San Benito County Health and Human Services Agency, Community  
10 Services and Workforce Development (CSWD) Division has received a Workforce Innovation &  
11 Opportunity Act (WIOA) Title I Master Subgrant, Youth Program Allocation, in the amount of  
12 \$202,210 which will provide 100 percent of the funding for the Youth Program during Program Year  
13 2016-2017.

14 NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors for the County of San  
15 Benito, State of California, that the Board hereby accepts and receives the WIOA Title I Master  
16 Subgrant, Program Year 2016-2017 Youth Program allocation for and on behalf of the County of San  
17 Benito; and

18 BE IT FURTHER RESOLVED that the Board of Supervisors hereby authorizes and directs  
19 the Chair of the Board of Supervisors or the Director of Health & Human Services Agency, to sign,  
20 execute, and submit subgrant agreements and any other WIOA documentation and/or amendments  
21 related to the subgrant for and on behalf of the County of San Benito.
