**WHEREAS**, the State of California (the "State"), Department of Housing and Community Development ("Department") has a current contractual relationship with the County of San Benito Department of Community Services and Workforce Development ("CSWD"), through its Office of Migrant Services Program (OMS) ("Program") for the purposes of managing and maintaining the OMS Hollister Migrant Center, which was formalized through the execution of Standard Agreement #15-OMS-10550.

**WHEREAS**, the OMS Program and the County of San Benito CSWD have agreed that the OMS Center is in need of rehabilitation and improvements to best serve the health and safety needs of the residents in accordance with the California Codes of Regulations Sections 7600-7665.

**WHEREAS**, the County of San Benito CSWD commits to facilitate the rehabilitation and improvements at the Hollister Migrant Center and agrees to provide direct project management and oversight to the work performed in accordance with all OMS Program requirements, all applicable state and federal rules and laws, and in a manner consistent and in compliance with the Standard Agreement between the County of San Benito CSWD and the Department.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Supervisors of the County of San Benito hereby amends Resolution 2016-33 with Contract No. 15-OMS-10863, with a rehabilitation budget in the amount not to exceed (\$25,496.00), be approved by the Director of the San Benito County Health & Human Services Agency is authorized to execute this Standard Agreement and any amendments or modifications thereto, as well as any other documents which are related to the Program, as the Department may deem appropriate, on behalf of the County of San Benito CSWD.
