WHEREAS, California Gov. Code §25355 authorizes the Board of Supervisors of San Benito County to accept any gifts, bequests, or devises made to or in favor of the County and further authorizes the Board to delegate to any county officer or employee the power to accept any gift, bequest, or devise made to or in favor of the county and establishes the reporting requirements associated with the acceptance of such gift, bequest, or devise; and

WHEREAS, Safe Kids Worldwide Coalition, a global organization dedicated to protecting children from unintentional injuries has agreed to enter into an agreement with San Benito County Public Health Services to form a local coalition called Safe Kids Coalition of San Benito County which will build a broad based structured community coalition with the mission of reducing unintentional childhood injuries in San Benito County; and

WHEREAS, through its partnership with Safe Kids Worldwide Coalition, Safe Kids Coalition of San Benito County is likely to receive monetary and property donations related to child injury prevention from various Safe Kids affiliates, partners and other community organizations;

WHEREAS, in order to expedite the acceptance of funds and other gifts offered for the prevention of child injuries to Safe Kids Coalition of San Benito County, Public Health Services is requesting the Board authorize the Director of Health and Human Services Agency to accept these gifts, bequests, or other donations consistent with the provisions of Gov. Code §25355.

NOW THEREFORE BE IT RESOLVED THAT: The Board of Supervisors of the County of San Benito hereby authorizes the Director of the County of San Benito Health and Human Services Agency to accept donations on behalf of Safe Kids Coalition of San Benito County consistent with the provisions of Gov. Code §25355.
