ORDINANCE NO. 828

The Board of Supervisors of the County of San Benito ordains the follows:

SECTION 1. REPEAL OF ORDINANCE NO. 752

Ordinance No. 752 entitled "An Ordinance Setting the Compensation and Reimbursement for the Expenses of the Board of Supervisors" adopted on May 28, 2002 by the San Benito County Board of Supervisors is repealed in its entirety and superseded by this ordinance.

SECTION 2. COMPENSATION

Each member of the Board of Supervisors shall be paid as compensation for his or her services a monthly salary of three thousand seven hundred and twenty one dollars (\$3,721).

SECTION 3. ADJUSTMENTS TO COMPENSATION

During any calendar year when there is an adjustment to the salary provided to the Superior Court Judges in San Benito County that same percentage increase shall be granted to members of the Board of Supervisors for an amount not to exceed the percentage cost of living increase provided to the general employees of San Benito County in that same calendar year.

SECTION 4. EXPENSES

Reimbursement for county related business expenses incurred by members of the Board of Supervisors is governed by Resolution No. 2006-70 entitled "A Resolution of the Board of Supervisors of the County of San Benito Adopting Travel and Expense Reimbursement Policy in Accordance with AB 1234" adopted by the San Benito County Board of Supervisors of June 27, 2006.

SECTION 5.

BENEFITS

Benefits shall be authorized for members of the Board of Supervisors in the same manner and to the same extent as they are generally authorized for department heads in County service.

SECTION 6.

ENACTMENT

Pursuant to Government Code § 25123.5, this ordinance shall take effect and be in force sixty (60) days from the date of its passage; and before the expiration of fifteen (15) days after its passage it, or a summary of it, shall be published once, with the names of the members of the Board of Supervisors voting for and against the same in a newspaper of general circulation published in the County of San Benito.
