CAO Ray Espinosa announced that there were some Department Head announcements from the following:

Health and Human Services Director James Rydingsword reported on his trip to a high tech recycle center in Indianapolis on June 1st with Brent Barnes. He said that it was a very positive experience and that they learned a lot and that they would be coming back on June 28th with a full report.

Resource Management Agency Director Brent Barnes said that the tour of the high tech recycle center was truly a moving experience. He said that it would be a great

opportunity for the County to explore. He said as Jim mentioned they would be making a much more detailed report at the next meeting.

Clerk of the Board/Interim Management Analyst Louie Valdez updated the Board on the Laser-fiche technology that is now online for the public, free of charge, and to the staff members to search the data base. He also spoke in regards to the sales tax measure and deadlines for putting that on the ballot for November. Supervisor Margie Barrios reported that she attended the Pajaro River Watershed Authority meeting and the discussion was the ongoing request from Washington for funding for the Pajaro River levy. She also spoke in regards to the massacre in Orlando, Florida and that she supported those who spoke in regards to it. She said, "I think we do have to step it up as the Board of Supervisors to have a resolution to support safety." She said that she was personally affected, as they have family and friends that are lesbian and the thought of losing them would be heart breaking. She said that she would like to make the request to proceed with a Resolution of some kind.

Supervisor Jerry Muenzer said that he too was appalled as to what happened in Florida. He said that it is truly heartbreaking.

Supervisor Anthony Botelho said that it is absolutely heartbreaking it is not what we need in this country. Prayers go out to the victims of that tragedy. He said that we need to work together and support each other so that it doesn't happen again, we are all Americans.

He also thanked the people who came out and voted last Tuesday. He said that it is a privilege and honor to serve as District 2 Supervisor and serve San Benito County and looks forward to working hard for the next four and a half years. He said that Measure P did fail and the condition of our roads is a necessity and that we need to address it. We need the special tax to leverage state revenue to help us with state highway projects as well as fixing our county and city roads.

He said that we also need to take up the issue that Mr. Zuniga mentioned during public comment on the Gavilan College Board.

Chairman Robert Rivas said in regards to the Gavilan College issue he would like to appoint Supervisor Margie Barrios and Supervisor Anthony Botelho to work with the CAO Ray Espinosa in regards to some options.

He said that he was glad that the sales tax issue was mentioned and would like to have a special meeting.

CAO Ray Espinosa said that they had tentatively scheduled the sales tax issue for the meeting of June 28th.

Clerk of the Board Louie Valdez provided information on the timeline to get it to the Elections Department.

Chairman Rivas also spoke in regards to the tragedy in Orlando, Florida and how it impacts us locally. He spoke as to how the LGBT community have been victims and are being attacked and discriminated against.

He said that we need to send a message to the LGBT residents here in San Benito County that we support them as a Board, and I support them as a Supervisor. He said that he hopes that this Board will create a LGBT study group to be more inclusive and supportive of our local residents.

He said that he would like to create a committee that consists of himself and Supervisor Margie Barrios to work with the CAO to do a resolution in San Benito County.

RMA Director Brent Barnes provided a option of eliminating the road crew. He said that is not a way that he wants to go. We would have to lay off a half a dozen workers, we already have four empty positions right now.
