The Chair entertained public comment for agenda items NOT listed on the agenda.

Karsen Klauer, City of Hollister Council Member, expressed concerns regarding allegedly delayed tax bills being mailed by the San Benito County Tax Collector's Office.

Marci Huston, proprietor of Garden Mart in the City of Hollister, registered a complaint regarding the County's and City's lack of responsiveness as it relates to her concerns about homeless persons disrupting her place of business on San Benito Street.

The Chair indicated he would follow up with staff to address the matter.

Mary Schneider, Vice President of the San Benito County Friends of the Library, informed the Board of the Summer Reading Program and thanked Union Bank for their contribution of \$500.00.

Mr. Marty Richman spoke about his concerns regarding Gavilan College and his meet-and-greet meeting with the newly appointed President of that institution. He asked that Gavilan be asked to put together a five-year plan to address needs in San Benito County.

d. Department Head Announcements: Information Only

The Chair recognized CAO Espinosa to begin Department Head and Staff Reports.

Joe Paul Gonzalez, County Clerk-Auditor-Recorder, informed the Board of the impending filing deadline to run for public office in San Benito County.

Nora Conte informed the Board about the Summer Reading Program at the Free County Library.

Karen Overstreet, County Agriculture Commissioner, informed the Board that her department has completed the annual crop report. The crop yield this year surpassed last year's yield which accounts for \$360 Million USD.

Brent Barnes, Director of the Resource Management Agency, reported that he met with the Hollister High School District to discuss the regional park and the County's response to the Environmental Impact Report. He also met with the Hollister School District (K-8) to create an umbrella MOU for joint use of park and school facilities County-wide in addition to specific agreements for each location (park/school).

On August 9th, Mr. Barnes plans to present a General Plan Implementation Update to the Board. He is also preparing code provisions for the CR Zone along Highway 101 which will be presented to the Planning Commission.

Jim Rydingsword, Director of the Health and Human Services Agency, reported that the 2014 CDBG Grant Conditions have been met and the County will be reimbursed for the expense of purchasing the 1161 San Felipe Road property. He also announced that the 2016 CDBG Grant Public hearing will be presented and the County is eligible to apply for this grant. In addition, over-the-counter grant funds will be applied for by the County at the request of the state.

CAO Espinosa announced the Countywide Employee Bar-B-Q on Thursday, July 28th.

Regarding the budget, the CAO announced that the formal budget adoption will likely take place in late September.

The CAO announced that Louie Valdez, the current Clerk of the Board, has been

hired as the County's new Management Analyst. Chairman Rivas implored the public to take a good look at the person at the podium and to send any and all requests directly to him.

Fire Chief Bob Martin Del Campo provided the Board with an update regarding staffing levels including lay offs of twelve (12) fire fighters. The first round of the grants issued by FEMA was announced last week and it did not include the City of Hollister. To date, two rounds have been completed and there are three rounds pending that might include the City of Hollister.

The Fire Chief also discussed mutual aid support and an update regarding the various fires around the state.

e. Board Announcements: Information Only

The Chair recognized Supervisor Barrios.

Supervisor Barrios congratulated the Clerk of the Board on his promotion and thanked him for his service. She also announced her attendance at the Mobility Partnership Meetings.

Vice Chair De La Cruz announced his attendance at the Council of Government Meetings and his education regarding STIP funding. He informed the Board that Greg Cox from San Diego County was elected second vice president of NACO.

Supervisor Muenzer announced his attendance of the State Department of Parks and how it affects the OHMVR Program that runs Hollister Hills. Supervisor Muenzer asked that an agenda item be placed on the next agenda, an item be placed on the agenda to support HR 1838, the Clear Creek Bill. He also asked that the Board also agendize support of the Northern Most Route as discussed by the Mobility Partnership. He also received notification that Caltrans is conducting pot hole repair on Highway 25 which may cause traffic delays.

Supervisor Botelho also congratulated the Clerk of the Board and advised that there are plenty of hours in the day to do both jobs. Mr. Botelho also agreed with Mr. Muenzer regarding the STIP funding. He also attended the Regional Park Meeting and advised that the County must be more diligent to schedule regular meeting with all agencies to keep the project moving forward.

He also attended the Business Council Meeting where he met the new President of the Gavilan College District and he advised he was heartened on the new President's views in serving the community. He further indicated the Board should reach out and invite her a Board Meeting.

The Board Chair also congratulated Mr. Valdez on his promotion to the Management Analyst's position and he thanked him for all his work as Clerk of the Board on implementing new technologies in the Clerk's office on behalf of San Benito County.

Chairman Rivas asked today's board Meeting be adjourned on behalf of two

individuals including Mr. Gino Carter, who passed away, who had a significant positive impact on youth in San Benito County and Northern California as well as Giovanni Gonzalez, a student at San Benito High School with whom Chairman Rivas worked, who left us much too soon.

The Chairman's request was so ordered without objection.

homeless individuals. She also commented on the services offered by My Father's House and how valuable those efforts are to San Benito County.

Steve Gedested with Keenan and Associates made the first presentation to the Board on behalf of his firm.

CSAC-EIA Representative Tom Sheeerr presented his firm's proposal to the Board.

Public Comment ensued with various retirees and employee groups addressing the Board as follows:

Laura Nacarato addressed the Board with SEIU on the Health Insurance Committee addressed the Board to request lower health insurance costs.

Suzie Caston address the Board with SEIU on the Health Insurance Committee requested that the Board provide lower health insurance costs.

Mark Wyrick, organizer with SEIU, also asked the Board to vote for lower health insurance rates.

Judy Johnson, retiree, asked that the Board to take the needs of the retirees into consideration when making their decision. She urged that the County stay with CalPERS.

Ellen Campos, Assistant District Attorney, President of the Management Employees Group along with Kathy Postigo, urged the Board to remain with CalPERS.

Margie Riopel, former County Management Analyst, urged the Board to remain with CalPERS.

Katherine Shaw and Pat Loe submitted speaker cards but were not present when their names were called.

Elsie Marshall, a San Benito County Retiree, urged the Board to remain with CalPERS.

Marty Richman, resident of the City of Hollister, advised the Board that should form a committee with authority to vote for the bargaining units that may or may not include the retirees so that the bargaining units come up with a consensus recommendation.

Keith Brown with Keenan and Associates provided responses to questions that were raised by some of the previous speakers who were retirees.
