#### ATTACHMENT A to Planning Commission Resolution

## California Environmental Quality Act (CEQA) Finding:

**Finding 1:** That the IS/MND produced for the previous Project was prepared in compliance with the provisions of the California Environmental Quality Act, the State CEQA Guidelines and the San Benito County Implementing Procedures for the California Environmental Quality Act.

### **Subdivision Findings:**

Finding 1: The recorded Parcel Map is consistent with the General Plan or any applicable specific plan.

## **Conditions of Approval:**

All prior conditions of approval for Minor Subdivision 1233-13/Use Permit #1079-13 shall remain in effect except for the proposed revision to Condition No.15.

Condition no.15 shall be revised as follows:

- **15. Roadway Improvements:** Subsequent to recordation of the Parcel Map the applicant shall bond for or make the following roadway improvements:
  - Half of 56 foot AC on 66 foot road bed (AB) along the property frontage of Buena Vista Road pertinent to the frontage of properties that have been approved for on-site improvements.
