

A RESOLUTION AUTHORIZING A MEMORANDUM OF UNDERSTANDING TO PARTICIPATE IN THE SUBMISSION OF AN APPLICATION FOR FUNDING WITH THE CITY OF HOLLISTER AND THE CITY OF SAN JUAN BAUTISTA AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO FROM THE 2020 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM-CORONAVIRUS RESPONSE ROUND (CDBG-CV1) NOFA DATED JUNE 5, 2020.

BE IT RESOLVED by the County Board of Supervisors of the County of San Benito as follows:

SECTION 1:

The County Board of Supervisors has reviewed and hereby approves the submission to the State of California of an application in the aggregate amount, not to exceed \$316,267 for the following CDBG-CV1 activities, pursuant to the June 2020 CDBG-CV1 NOFA:

- A. Public Service - Rental Assistance to eligible low- and moderate-income applicants residing in San Benito County and affected by CV1: \$101,532.00.**
- B. Public Service- Rental Assistance to eligible low- and moderate-income applicants residing in the City of Hollister and affected by CV1: \$151,177.00**
- C. Public Service – Rental Assistance to eligible low- and moderate-income applicants residing in the City of San Juan Bautista and affected by CV1: \$ 63,558.00**

SECTION 2:

The County of San Benito acknowledges compliance with all state and federal public participation requirements in the development of its application.

SECTION 3:

The County hereby authorizes and directs the Director or Deputy Director of Health and Human Services Agency (HHSA) to execute the Memorandum of Understanding, grant application, standard agreement and all amendments thereto and act on the County's behalf in all matters pertaining to all such agreements.

SECTION 4:

If an application is approved, the Director of Health and Human Services, or Deputy Director designee, is authorized to enter into, execute and deliver the grant agreement and any and all subsequent amendments thereto with the State of California for the purposes of the grant.

SECTION 5:

If an application is approved, the Director of Health and Human Services, or Deputy Director, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
