Dear Joel,

In light of the current COVID situation in San Benito County, PORC has directed me to request that you ask the Board of Supervisors to convene a special or emergency meeting by telephone or videoconference, consistent with Gov't Code sec. 54956 and/or 54956.5, to deliberate and vote on a resolution to suspend the effective date of Ordinance 1016 rezoning a portion of the Searle Rd./SR 129 commercial node until 30 days after the County moves to "Tier 3: Moderate" status, and vaccines are available to signature gatherers. which is reflective of the situation the County was facing in June, 2020, when the "Guidance for Petition Circulation" was issued by the Interim Health Officer.

Today, San Benito County's number of confirmed COVID cases is about 27 times the number of confirmed cases on June 3, 2020 when the County Health Officer issued "Guidance for Petition Circulation". The County's COVID status was Tier 3: Moderate on June 3, 2020. Today, the County's COVID status is Tier 1: Widespread. The June Guidance is therefore no longer relevant or reflective of current conditions.

As Dr. Mark Ghaly, the state's Health and Human Services Secretary, observed in his December 29, 2020 COVID update, "Things that were a month ago, or two months ago, a low-risk activity, today are really high risks because of the level of COVID that's circulating in our communities". The County's COVID test positivity rate is now more than twice that of Santa Clara and Santa Cruz counties. Below is the latest COVID data from San Benito County Health Department's website.
