15	Benito hereby accepts the 2022 CSBG grant, approves the grant agreement (2022 CSBG Contract #22F-5034) with the State of California Department of Community Services & Development, and authorizes the HHSA
16	Director or Deputy Director to take all actions necessary to administer the grant, including entering into and signing the grant agreement, any amendments to the grant agreement, and other documents related to the grant, and to perform any and all responsibilities in relationship to such grant, for and on behalf of the County of San Benito.
