8 **WHEREAS**, the County of San Benito is eligible to participate in the Youth Programs and
9 Facilities Grant Program funded through the California State General Fund and
10 administered by the Board of State and Community Corrections; and

11 **WHEREAS**, the San Benito County Probation Department submitted a Youth Programs
12 and Facilities Grant application under Part B for Youth Programs, for approval of grant
13 funding for staffing the Partners Achieving Change Together (PACT) team, for
14 implementation of SB 823 Juvenile Justice Realignment; and

15 **WHEREAS**, the Board of State and Community Corrections has informed the Probation
16 Department that a conditional grant in the amount of \$144,000.00 has been awarded.

17 **NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of San
18 Benito that it hereby authorizes and directs the Chief Probation Officer or designee to
19 accept the Youth Programs and Facilities Grant Program grant funds, for and on behalf of
20 the County of San Benito; and

21 **BE IT FURTHER RESOLVED** by the Board of Supervisors of the County of San Benito
22 that the Chief Probation Officer or designee is hereby authorized to enter into, execute,
23 and deliver a Grant Agreement with the Board of State Community Corrections, as well as
24 any and all other documents required or deemed necessary or appropriate to evidence and
25 secure the grant and the County's obligations related thereto, any amendments thereto, for
26 and on behalf of the County of San Benito; and

27 **BE IT FURTHER RESOLVED** by the Board of Supervisors of the County of San Benito
28 that it hereby agrees that the grant funds received hereunder shall not be used to supplant
expenditures controlled by the Board of Supervisors; and

29 **BE IT FURTHER RESOLVED** by the Board of Supervisors of the County of San Benito
30 that it hereby agrees to abide by the terms and conditions of the Grant Agreement as set
31 forth by the Board of State Community Corrections.
