

RESOLUTION NO. 2022-20

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLISTER TO ALLOW THE HOLLISTER FIRE DEPARTMENT TO SUBMIT A 2022 SENATE DISTRICT 12 BUDGET REQUEST TO THE OFFICE OF SENATOR ANNA M. CABALLERO

WHEREAS, the Hollister Fire Department is requesting approval from City Council to submit a 2022 Senate District 12 Budget Request to the office of Anna M. Caballero, Senate District; and

WHEREAS, the budget request should be limited to the most pressing budget priority projects (1-2 projects); and

WHEREAS, Senator Caballero will review for possible funding allocation from the state budget and proposals should address critical community and infrastructure needs; and

WHEREAS, projects may include Capital Improvement Projects including construction or improvement of critical facilities such as public safety; and

WHEREAS, the Hollister Fire Department has identified projects within the City of Hollister in which the City, along with neighboring communities through Auto Aid and Mutual Aid Agreements, have a significant gain in services to the community if selected to be funded with this grant; and

WHEREAS, there is no guarantee funding will be allocated, these budget requests provide Senator Caballero with information about the most pressing budgetary needs within her district.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Hollister approve the Hollister Fire Department to submit a 2022 Senate District 12 Budget Request to the office of Anna M. Caballero, Senate District 12.


