the San Benito County Planning

Commission for the adoption of an ordinance amendment to repeal existing Chapter 25.29, Article IV.

Business in the Home, sections 25.29.090 to 25.29.104 in their entirety and the replacement with new provisions relating to Home Occupations and Rural Home Enterprises, at which time and

place interested persons may appear and be heard.

## SUMMARY OF THE PROPOSED ORDINANCE

Section 1 of the proposed ordinance makes findings with regard to consistency of the proposed ordinance with the 2035 San Benito County General Plan

and the protections of the public health, safety, and welfare, and that the proposed amendments are not subject to the California Environmental Quality Act (CEQA). Section 2 deletes the current

text of San Benito County Code Chapter 25.29, Article IV. entitled Businesses in the Home, Sections 25.29.090 to 25.29.104 in their entirety.

Section 3 amends the San Benito County Code to add Chapter 25.29, Article IV. entitled Home Occupations and Rural Home Enterprises, sections 25.29.090 to 25.29,096 including definitions and regulations regarding Home Occupations, and section 25.29.097 to 25.29.108 including

regarding Rural Home Enterprises, in part to make the regulations more consistent with state law. Section 4 provides for the effective date and codification of the ordinance.
