Title 25: Zoning Ordinanc Update:

This ordinance will repeal San

Benito County Code Title 25 entitled Zoning in its entirety and amends the San Benito County Code to add new Chapters 25.0 to 25.09 of Title 25 entitled Zoning, including table of contents, general provisions

and administration, permits and other planning actions zoning map and zoning districts, combining zones, planned unit development, specific plans, general development and design standards, standards for specific uses and areas, and glossary, in part to make the regulations more consistent with state law, achieve the vision and goals outlined in the 2035 General Plan, and make the code more clear, concise, and user friendly.
