

AMENDMENT TO CONTRACT

The County of San Benito ("COUNTY") and JOHN TOMLINSON, A SOLE PROPRIETORSHIP DBA LEVEL 1 PRIVATE SECURITY, ("CONTRACTOR") enter into this agreement on the date stated next to the signatures below. In consideration of the mutual promises set forth herein, the parties agree as follows:
