Budget Officer Melinda Casillas gave a presentation on the general overview of where we are in the budget process for the FY 18/19.

The PowerPoint presentation covered: Overview of what we are doing right now; Budget timeline setup; CAO's Office; What are we seeing; San Benito County issues; Roads; Retiree Medical: PERS; Staffing; Revenue-Static; Facilities & Infrastructure; Technology; Items in the pipeline; Revenue Opportunities; Expense savings opportunities; Review of the Budget Policies; Budget agenda format; questions and comments.

Supervisor Mark Medina had a question in regards to what a document transfer tax was.

Ms. Casillas provided information.

Discussion by Board and staff in regards to fee schedule and revenues.

# 2. <u>COUNTY CLERK-AUDITOR-RECORDER-ELECTIONS - J. P. GONZALEZ</u>

Receive Pension update and hold discussion.

Budget Officer Melinda Casillas provided information and presentation in regards to the overview of the entire budget year to date. She provided information in regards to the ERP system and how it works for the budget.

Ms. Casillas provided information in regards to revenue: 53% right now, including the PVS (Solargen) payment of 2.5 million dollars, 65% through this fiscal year. 46% of our expenses right now, which includes salaries, benefits and cola. She said that we are on schedule with salaries and benefits. The revenue totals are a little bit higher than normal, due to the PV2 (Solargen)payment we received and expenses are a little bit lower. She said that a lot of the expenditures will appear in the next 3 months. She said that this report shows all of the funds.

CAO Ray Espinosa explained that the Resource Management Agency has been going through some transitions so there is going to be some billing going out and some revenues being received. He also mentioned that in the 3rd and 4th quarter we would also be receiving more revenues.

Ms. Casillas provided information on general revenue's that goes to the net county cost of general fund departments: Property tax we are at about 60% collected; sales tax 81%; other taxes 69%.

Supervisor Jaime De La Cruz had a question in regards to sales tax.

Ms. Casillas provided information.

Ms. Casillas said there is a 1.8 million dollars in vacancies in the general fund this year. She said that money is used to help departments when they are falling short on some of their projected costs.

Discussion by Board and staff in regards to short falls and vacancies.

Ms. Casillas provided information on Economic factors Trend for FY 12/13-FY 17/18 (Budgeted).

Those speaking from the public were: Marty Richman, Hollister resident, asked if we do a 5 year projection and what are the factors to show what the pot will be in these different categories.

Supervisor Mark Medina provided information to Mr. Richmans question.

CAO Ray Espinosa provided additional information. He said that we will have more information at our next special meeting in May.

Mr. Espinosa said that administration is looking at other sources of revenue, one of our key aspects of revenue in our County is property taxes.

Mr. Espinosa thanked Ms. Casillas for all her hard work in tracking the budget, etc.

County Counsel Barbara Thompson provided information on the three issues before the Board today; Full Text Publication; Fiscal Impact Analysis; and the Arguments for the Ballot Measure for

the June 2018 election. She said at the end of discussion they will be asking the Board for three actions; Adopt Resolution; approve the ballot argument; and delegate to the Chair the authority to make any minor modifications that is necessary to submit the ballot arguments.

Ms. Thompson said that they are recommending that the full text be placed on the county website and be mailed out at no cost; that the Auditor do a fiscal impact analysis for each ballot measure and that ballot arguments be signed by the Chair.
