WHEREAS, the County of San Benito purchased a 1999 Dodge Caravan (license plate #1112208) for use by the Health & Human Services Agency (HHSA) in its operations; and

WHEREAS, the 1999 Dodge Caravan has in excess of 150,000 miles and is no longer being used and will not in the future be required for County purposes or other public use; and

WHEREAS, Government Code Section 25372(b)(5) allows the County Board of Supervisors to donate surplus property that is not required for County use to an organization exempt from taxation pursuant to 26 U.S.C. section 501(c)(3) that is organized to provide health or human services and upon any terms or conditions determined by the Board to be appropriate; and

WHEREAS, Community Homeless Solutions (CHS) is a non-profit 501(c)(3) organization that is currently operating the San Benito County HOME Resource Center and providing homeless services to residents of San Benito County; and

**WHEREAS**, CHS is in need of an additional vehicle to provide daily transportation for its clients to and from the HOME Resource Center and intends to use the 1999 Dodge Caravan for this purpose; and

WHEREAS, the County desires to assist in this effort to improve services to the homeless population in San Benito County.

**NOW THEREFORE BE IT RESOLVED** by the Board of Supervisors of the County of San Benito as follows:

- 1. The 1999 Dodge Caravan fixed asset, license plate #1112208 is hereby declared to be surplus property.
- 2. Pursuant to Government Code Section 25372, the Board finds the property and all interests to be donated are not required for County purposes.
- 3. Pursuant to Government Code Section 25372, the Board determines that CHS's proposal benefits the homeless population and serves a public purpose.

- 4. Pursuant to County Purchasing Ordinance §5.09.008(A), the Public Works Administrator is authorized to execute all documents necessary for the transfer of title of the 1999 Dodge Caravan, license plate #1112208 to Community Homeless Solutions to be used for transporting clients to and from the HOME Resource Center.
- 5. The County Auditor is directed to remove the surplus vehicle from the capital assets list upon report of ownership transfer having been completed.
