WHEREAS, NOTICE IS HEREBY GIVEN OF INTENTION TO SELL FOR THE STATED MINIMUM PRICE, at Public Auction via the Internet, the tax-defaulted property which is subject to the power of sale and described in Exhibit "A" attached hereto and incorporated by reference, in accordance with Chapter 7 of Part 6 of Division 1 of the California Revenue and Taxation Code; and

**WHEREAS**, the Tax Collector in her discretion has determined that the property specified in Exhibit "A" should be offered for sale, over the internet, on September 28, 29, 30, and October 1, 2018, with the minimum bid to be in accordance with California Revenue and Taxation Code Section 3698.5; and

WHEREAS, California Revenue and Taxation Code section 3698.5 provides that, where property has been offered for sale at least once and no acceptable bids therefore have been received at the prescribed minimum price, the Tax collector may, in her discretion and with the approval of the Board of Supervisors, offer that same property at the same or next scheduled sale at a minimum price that the Tax Collector deems appropriate in light of the most current assessed valuation of that property or any unique circumstance with respect to that property.

WHEREAS, the Tax Collector in her discretion has requested the Board of Supervisors' authorization to sell the property specified in Exhibit "A" over the internet, on September 28, 29, 30, and October 1, 2018, and to re-offer any property that is not sold within 90 days of the original date, in accordance with California Revenue and Taxation Code Sections 3692(e) and 3698.5(c); and

**NOW THEREFORE BE IT RESOLVED** that the San Benito County Board of Supervisors hereby approves the sale of tax-defaulted property subject to the power of sale and any continuation of the sale is hereby approved.

BE IT FURTHER RESOLVED that the San Benito County Board of Supervisors hereby authorizes and directs the Tax Collector of the County of San Benito to offer the property, described in Exhibit "A", at public auction, over the internet, to the highest bidder for cash in lawful money of the United States at the minimum bid set in accordance with California Revenue and Taxation Code Section 3698 et. seq.
