A RESOLUTION OF THE SAN BENITO Resolution No. 2018-___ COUNTY BOARD OF SUPERVISORS AUTHORIZING THE ACCEPTANCE AND EXECUTION OF THE EASEMENT DEED FROM THE SAN BENITO HIGH SCHOOL DISTRICT TO SAN BENITO COUNTY FOR CONSTRUCTION OF THE NASH ROAD BYPASS

WHEREAS, the San Benito High School District ("SBHSD"), the County of San Benito ("County"), and the City of Hollister entered into an Interagency Cooperation Agreement (Regional Park Project/Nash Road Closure), effective as of November 21, 2016 ("Interagency Agreement"), as amended on October 5, 2017; and

WHEREAS, the Interagency Agreement described the concerns regarding San Benito High School students crossing Nash Road, between West Street and Monterey Street, to attend classes and athletic events on the District's bisected High School Campus, and parties' desire to close Nash Road to vehicular traffic during and after school hours ("Nash Road Closure"); and

WHEREAS, the Interagency Agreement provided, among other things, for (i) the creation of a public road to provide access to the Regional Park as set forth therein and to accommodate the Nash Road Closure ("Nash Road Bypass") and for (ii) a grant of a non-exclusive easement from SBHSD to the County over SBHSD property on which the Nash Road Bypass would be constructed by the County ("Public Road Easement"); and

WHEREAS, The Public Road Easement is subject to, and coordinated with, a water pipeline easement granted to Sunnyslope County Water District by SBHSD for the installation of water pipelines by the County underneath the Public Road Easement pursuant to that certain Memorandum of Understanding by and between the County of San Benito and Sunnyslope County Water District dated as of April 3, 2018; and

WHEREAS, SBHSD has executed and delivered to the County an easement deed 1 granting the Public Road Easement to the County attached hereto as Attachment A 2 3 ("Easement Deed"); and WHEREAS, it is in the best interests of the County to accept, execute and record 4 5 the Easement Deed in the Official Records of San Benito County. 6 NOW, THEREFORE, BE IT RESOLVED that the San Benito County Board of 7 8 Supervisors hereby makes the following findings and determinations: Section 1. The foregoing recitals are true and correct. 10 Section 2. Public necessity and convenience require the acquisition of the property interests granted by the Easement Deed for the Nash Road Bypass project, and 11 12 acceptance of the property interests granted therein would advance, benefit, protect and serve the County's best interests, because they are necessary for proper construction and 13 14 maintenance of a public highway for road purposes. 15 Section 3.
