7	WHEREAS, Since completion of the River Parkway Master Plan several years ago, the
8	County has been working with its partners at the San Benito High School District and the
9	City of Hollister to acquire property for the park to begin implementing the first phase or
10	the proposed park project; and
11	WHEREAS, upon execution of the multi-agency agreement between these three agencies
12	early last year, staff has been working on the design of the proposed Regional Park
13	Access Road; and
14	WHEREAS, this road is now under construction with a scheduled completion date in
15	mid-October this year; and
16	WHEREAS, This new road requires a name before construction is completed so that road
17	signs can be installed, maps can be updated, and emergency personnel notified of the
18	change; and
19	WHEREAS, section 971 of the California Streets and Highway Code provides that the
20	San Benito County Board of Supervisors or a county officer designated by the Board may
21	officially name any County highway which has not been officially named without any
22	hearing or notice;
23	WHEREAS, such naming shall be by an order duly made and filed with the Board of
24	Supervisors, and thereafter the highway shall be known by the name thus designated;
25	and
26	WHEREAS, due to a short timeline and the need for a clear, descriptive name for the
27	new road, RMA is recommending that the Board approve naming the new Access Road

as "River Parkway"; and

1	WHEREAS, "River Parkway" is the name that has been used throughout the project
2	development and construction process and plans for the future park project, and will
3	help the community find and access the proposed Regional Park and River Parkway trail
4	system once completed.
5	
6	NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of
7	San Benito that "River Parkway" is a clear and descriptive name for the new Access
8	Road; and
9	
10	BE IT FURTHER RSOLVED by the Board of Supervisors of the County of San Benito
11	that the new Access Road shall hereafter be named "River Parkway".
12
