8 **WHEREAS**, Since completion of the River Parkway Master Plan several years ago, the
9 County has been working with its partners at the San Benito High School District and the
10 City of Hollister to acquire property for the park to begin implementing the first phase of
11 the proposed park project; and

12 **WHEREAS**, upon execution of the multi-agency agreement between these three agencies
13 early last year, staff has been working on the design of the proposed Regional Park
14 Access Road; and

15 **WHEREAS**, this road is now under construction with a scheduled completion date in
16 mid-October this year; and

17 **WHEREAS**, This new road requires a name before construction is completed so that road
18 signs can be installed, maps can be updated, and emergency personnel notified of the
19 change; and

20 **WHEREAS**, section 971 of the California Streets and Highway Code provides that the
21 San Benito County Board of Supervisors or a county officer designated by the Board may
22 officially name any County highway which has not been officially named without any
23 hearing or notice;

24 **WHEREAS**, such naming shall be by an order duly made and filed with the Board of
25 Supervisors, and thereafter the highway shall be known by the name thus designated;
26 and

27 **WHEREAS**, due to a short timeline and the need for a clear, descriptive name for the
28 new road, RMA is recommending that the Board approve naming the new Access Road
29 as "River Parkway"; and

1 **WHEREAS**, "River Parkway" is the name that has been used throughout the project
2 development and construction process and plans for the future park project, and will
3 help the community find and access the proposed Regional Park and River Parkway trail
4 system once completed.

6 **NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of
7 San Benito that "River Parkway" is a clear and descriptive name for the new Access
8 Road; and

10 **BE IT FURTHER RSOLVED** by the Board of Supervisors of the County of San Benito
11 that the new Access Road shall hereafter be named "River Parkway".


