CAO Ray Espinosa provided background information in regards to the cannabis business tax that was voted on and passed on June 6th.

Management Analyst Dulce Alonso provided additional information in regards to the business tax and introduced David McPherson, Cannabis Compliance Director of HDL Companies who will present a PowerPoint presentation on their company and services for the implementation of cannabis regulatory.

Mr. McPherson provided additional information and the PowerPoint that covered the following: About HDL; Agenda; Draft Ordinance addressing key issues; Categories of use; Number of permits allowed; San Benito County Zoning Districts; Agriculture Productive, Agriculture Range land, Commercial District, Manufacturer District; Application process-What type of application process should the County consider; Application Selection Criteria process; fees and taxes; Fiscal Analysis-Cannabis Revenues estimates: Conservative \$2,097,600 - \$4,130,200 (37 Businesses), Moderate \$3,421,800 - \$6,688,600 (60 Businesses), Aggressive \$4,431,000 - \$8,737,000 (78 Businesses).

He said what they are needing from the Board is direction: What type of activities that you want to move forward with or what you don't want to move forward with.

CAO Ray Espinosa provided additional information and stated how this is a working process, but will need direction from the Board as how they want to move forward with what HDL presented.

Discussion ensued by Board and staff.

Chairman Botelho opened public comment:

Those speaking from the public were: Michael Caragio, Founder of Za Miracle, spoke in regards to plant science and strains and his business.

Tim McCord, County resident, asked the Board to take a hard look at the agriculture view in our County and what it is used for. We need to look at the health and welfare of the people who live here. I don't feel we need marijuana in our County we need agriculture.

Marlee Smith, Pinnacle Strategy, spoke in support of HDL Companies for the County of San Benito.

Sean Kali-Rai, Silicon Valley Cannabis Alliance, spoke in regards to signing contract with HDL

Companies.

Aaron Johnson, representing several applicants. He does support HDL's process. Supports outdoor grows.

Jack Kirk, said that people are concerned about having this close to their homes. HDL looks like a good company. It is not a quick revenue source.

Chairman Botelho said that they would continue this discussion after lunch. They were going to adjourn into closed session.

The Board reconvened back to regular session at 1:22 p.m. Continued with this item.

Elia Salinas, San Benito County resident, questioned why the Board had approved one pacific company (HDL) to come and present when there are other companies out there. Has there been a contract, etc. Spoke about outdoor grows should be done in South County.

Steve Becerra, said that HDL has a good work history and has worked with other County and Cities. This is a good move for the County.

Chairman Botelho closed public comment.

Chairman Botelho said that we are not going to get an ordinance done unless we get outside help. He said that HDL does work for other cities and counties and they have a lot of experience. He said the first and foremost is the development of a growing ordinance. The Board today needs to have a discussion as to what the process we would like to see going forward to finalize. He said possibly two ways of doing it; workshop format or have a committee formed to work with staff and HDL.

CAO Ray Espinosa said that the Board had directed this to move forward, but the concern that administration or staff has is depending on which direction your Board decides to go, are we going to generate enough revenue to have staff on hand. How are we going to handle it at a cost and revenue perspective. He said that is why they gave some scenarios in regards to some numbers.

HDL provided additional information on the scenarios and the different grows and the approximate amount of revenue it could generate.

CAO Espinosa said that is what we need to have from the Board to move forward is how many grows do you want in our County in order to be sustainable.

Discussion ensued by Board and staff.

CAO Ray Espinosa said that the contract is going to be more than \$10,000 we have a \$50,000 cannabis budget. He said that we have the contract right now to accept and then we need to give some direction to move forward.

Supervisor Jaime De La Cruz recommended that we approve contract with HDL and have them call each Supervisor to see what they would like to see and then bring back to the Board.

CAO mentioned that could be a concern with a violation of the brown act, we need to be very careful.
