CAO Espinosa invited Shawn Tennenbaum, Superintendent of the High School to give an update on projects.

Mr. Tennenbaum thanked the County for their partnership. Spoke in regards to the gates on Nash Road the bypass road and the traffic around the High School. He said that they would continue to work with the City Council and the County to see this project through. He thanked Adam

Goldstone and John Guertin for their outstanding job for the County. He said that they currently have about 3,000 students on campus; 300 employees; and every day they have over 10,000 crossings between one side of the campus to the other and that the safety measure to close Nash Road is tremendous, he thanked the Board for that.

Chairman Anthony Botelho said that he was going to read a statement that he received from Vicki Fortino, President of United Way, to the Board of Supervisors. She said that the San Benito County United Way voices support for Sun Street Center's alcohol and drug addiction recovery services being conducted in San Benito County. She said that we do not understand why a contract is being voted on by the Board for these services to be provided in Santa Cruz County when we have these services available in San Benito County with Sun Street Center. We ask that the Board reconsider this contract with Santa Cruz County and move forward with Sun Street Center and keep these vital services in our community.

Chairman Botelho opened for public comment.

Those speaking from the public were: Anna Foglia, CEO of Sun Street Center, spoke in regards to their center and their woman's program and how they are in jeopardy of loosing the program. She is trying to get a contract with medical to be able to provide medical services to their residents.

Patricia Garza, San Benito County resident, spoke in regards to her past recovery and how having a facility in San Benito County like Sun Streets for woman is nice.

Stephanie Hicks, Board Member for Sun Street Centers, spoke on behalf of the Board of Directors of Sun Street Center as to how they do not want the Board to renew contract with Encompass Services of Santa Cruz and to consider Sun Street Center in Hollister. They are asking the Board for their support to keep contract local.

Catherine Intravia, Program Manager of Sun Street Center, asked why can we not contract with San Benito County instead of Santa Cruz County. The program is very valuable and we should

keep resources locally.

Melissa Edwards, Director of Sun Street Center, spoke in regards to their facility and asked the Board that they reconsider contract and keep resources locally.

Mary Ellen Erickson, recovering addict, spoke in regards to how important it is to have these services in San Benito County and how she supports Sun Street Center.

Steven Reid, spoke for himself but works for Behavioral Health Department, spoke in regards to these services for San Benito County and that these are renewal contracts with Santa Cruz, it is not choosing one over the other.

Delina Watkins, resident of San Benito County, spoke of how she is in support of Sun Street Centers and how important that this program is in this community.

Chairman Botelho closed the public comment.

Behavioral Health Director Alan Yamamoto provided some background information in regards to the two contracts that the Board approved with Sun Street's at the last Board meeting. He said that hearing this today makes it look like we are not being a collaborative partner and that really bothers me. He said that we have been supporting and will continue to support them but under the circumstances right now with Sun Street's they are not a medical supporter and that would put them out of compliance with the State. So this contract that we are presenting today is to put us in compliance by the deadline of September.

Discussion ensued by Board and staff.

Chairman Botelho said that I don't think we are going to resolve this today, but would hope to enhance partnership with Sun Street's for these vital services in our community. He said that I think that we need to continue this discussion and probably have a sub committee to meet with Sun Street's and Behavioral Health to discuss this further.

Mr. Yamamoto said that his recommendation would be to approve the contract today with Encompass so that we can be in compliance.

# 23. RESOURCE MANAGEMENT AGENCY - J. GUERTIN

Consider a permanent, partial closure of Bonnie View Road, a public road, at the County and City line approximately 0.29 miles north of the intersection with Sunnyslope Road.

RMA Director John Guertin provided information in regards to partial closure of Bonnie View Road for the Boards consideration. He provided some historical contexts on the road and the condition of the road. He said if we do go forward with putting the barricade up it would require a traffic study and some environmental review and some kind of amendment to the general plan.

Discussion ensued by Board and staff.

Chief Bedolla provided information in regards to the State fire code and having an access road. He said that we want to keep the road open for public safety.

Chairman Botelho opened the public comment.

Those speaking from the public were: Jeannine Porteur DiVincenzo, Bonnie View resident, provided a PowerPoint as to why they do not want Bonnie View open to through traffic. Items covered were: Street View-Width; Bonnie View Road and Sunnyslope Road-East Corner; Middle of the Road Damage; West Side-Damaged Road Edge; East Side-Damaged Road Edge; Traffic Jam 11-14-17 New Development Construction; Safety Measures Proposed; Our wish for Bonnie View Road is for it to remain a dead end, as it has been for 67 years; Heavy equipment and road damage June-August 2018; New road damage since County filled potholes in January 2018; Existing barriers between City and County Roads in Hollister. She said besides the issues on Bonnie View Road this does not only involve the development at the end of Bonnie View Road but increased traffic on a lot of the near by roads. She said this is an accident waiting to happen.

Dee Slykas, Bonnie View resident, provided some bullet points and history of Bonnie View Road. She said that they would appreciate a census vote today from the Supervisors. She thanked Mark Medina for his dedication and time on this matter and their neighbors in voicing their opinions and helping to try and keep Bonnie View Road closed.

Chairman Botelho closed the public comment.

Supervisor Mark Medina said that this is a safety issue, so he is asking the Board to look at this and keep Bonnie View Road barricaded at the end, so it is not a through road.

Supervisor Robert Rivas thanked residents for expressing their opinions. Thanked Supervisor Medina for his diligence and representation in this area for his district. He said that he has some concerns about potential closure. He felt that the Chief brought up some good points. He brought up some concerns in the general plan. He said that he did not support the closure, that it was in our best interest to keep it open.

Supervisor Jaime De La Cruz thanked members of the Community for showing up and thanked Mark Medina for bringing this issue to the Board of Supervisors. He said that he concurred with Supervisor Rivas, he too has issues with closing the road. He said based on what the Chief said that he could not support closing this road.

Supervisor Jerry Muenzer thanked the members of the public for coming and showing their support. He had a question for County Counsel if they closed the road would the Supervisors be personally liable for doing that.

Interim County Counsel Laura Zagaroli said that County needs statutory authority to close a road and the only authority there is if there is a health and safety reason. If the County wants to take action and erect a barrier on the County side we would need authority to do that. She said that she would like to look into to this further in order to determine if the Supervisors would be liable.

Chairman Anthony Botelho thanked Ms. Porteur for bringing the information forward, very good presentation. Said that he had some concerns, but we have an obligation to address the safety issues. He said he cannot support the barrier staying up based on the information that has been provided. He said that he would bring it back to the Board for direction.

Ms. Porteur said that when the City met they voted to keep the barrier up until the County can make safety improvements.

Supervisor Muenzer asked if the City Council voted to put barrier up why is it not up.

Chief Bedolla provided information.

John Guertin said that he met with City Manager and staff and came to the same conclusion that they did not have the statutory authority to put the barrier back up, that is why it is not up.

Supervisor Mark Medina made a motion to put barrier on Bonnie View Road. There was no second so motion died.

RMA Director John Guertin provided information in regards to new contract to extend services by John Chapin for the slope stabilization on Southside Road. He said there has been a 4th slide out there and this is to continue work to finish cleanup work to stabilize the hillside. We will be regrouping to see what the next step is, and we will be getting a specialist out there to see what the cause could be.

Discussion endued by Board and staff.

Supervisor Jerry Muenzer said that Sunnyslope Water needs to be here to help come to a conclusion on this. He said that we are running out of time, this needs to be resolved soon. We need to suspend any future projects that are with Sunnyslope until we get this resolved.

Chairman Botelho said that he too agreed with Supervisor Muenzer. Spoke in regards to getting the road open, etc. He said that it is imperative that we get the answers from the experts as to what is causing the slides, because if the Southside Water District is to blame, we need to get it addressed as soon as possible.

Mr. Guertin provided additional information.

Supervisor Mark Medina questioned if we should wait until we get the cause and then finish what we have to do.

Greg Brutnel Engineer for Don Chapin provided information. He said that this contract is to finish up miscellaneous work from slide 3.

Chairman Botelho opened public comment.
