Mr. Yamamoto announced that this is the 29th Red Ribbon week that the Board has recognized. He thanked all the people who help with planning and participating in this event.

Chairman Anthony Botelho spoke about April England-Mackie being 2018 Agricultural Woman of the Year. He said that he presented a Certificate to her at the Ag Hunger event in Soledad last month.

He invited her to the podium and congratulated her on behalf of the Board of Supervisors for her service to her community and industry and for what she does for our County and the Region. He said that it was important that Ag Hunger recognized a young lady from San Benito County. Ms. Mackie said that it really humbled her to get this reward, she was among a great group of woman. She said that she feels honored that they recognized someone from San Benito County. She said that she is very passionate about the industry and helping the farmers and to help provide food for our nation. She thanked the Board for having her here today and recognizing her for this award.

Chairman Anthony Botelho presented Certificate of Recognition to Don Chapin III and the American Cancer Society for Breast Cancer Awareness Month.

Mr. Chapin with the Don Chapin Company spoke in regards to Breast Cancer Awareness Month and how it has effected someone in one way or another. He said that his family and Company has decided to take a stand, which they have commissioned a brand new pink concrete mixer. He said that they have come up with a program to raise money to go to the American Cancer Society or Susan G. Komen, etc. to honor loved ones that are fighting or have lost the battle to cancer. He said for a donation of \$100.00 you can put a loved ones name on the side of the mixer that will live there for the life of the truck, he said that they hope to fill the entire drum with names. He said he has left flyers in the back of the room and if someone is interested in putting the name of a loved one on the truck they can contract them. He said that there goal for this truck is to raise a million dollars. He said if there are businesses that would like to donate \$2,500.00 they would put

there business logo in full color on the truck.

Chairman Botelho said it is Company's like Chapin's that makes a difference in these issues. He said that the Board of Supervisors wants to thank the Chapin Company for their efforts in this matter and other's that they contribute to.

d. Public Comment

Those speaking from the public were: Sheila Cordova, IHSS Worker, spoke about being a in home support provider an how that she would like to make more money and feel that their work is valued.

Irma Gonzales, IHSS Worker, spoke about being a in home care worker for her daughter who is disabled and how the pay of IHSS workers is very low in our county. Would like to be compared to other IHSS workers in other counties.

Mickie Luna, City Council Member of District 2, thanked Supervisor Mark Medina, Anthony Botelho, Robert Rivas and Jerry Muenzer for the support they have given her the past four years as a City Council member and trying to improve the west side of the City of Hollister. She spoke of non support from elected officials such as Supervisor Jaime De La Cruz. She asked the Board for their continued support in regards to grant funding for the west side of Hollister.

Janette Martinez, Youth Alliance MSW Student, read a letter on behalf of parent in regards to their sons learning behaviors and how they would have liked specialized help from the school's and the county.

Jeanette Neal, works with Youth Alliance, spoke in regards to working with parents in regards to pertaining to mental health. She said that she feels that our Behavioral Health Department is not able to provide services to meet the needs of our community. She said that she is here with a group of people who would like to share their stories.

Those sharing their stories and stating the need for mental health services in the County and in the Schools were: Lorena Jacques, Youth Alliance Parent; Naeyina Jacques, Student with Youth Alliance; Javier Renteria, Youth Alliance Student.

Erica Elliott, Program Manager of Community Solutions, spoke in regards to the mental health services in the County and the increase of support that is needed.

Diane Ortiz, Executive Director of Youth Alliance, spoke in regards to the extreme disconnect between mental health services and the community and a broken system. She said that they are asking the Board of Supervisors to put the issue of mental health a priority and agendize this issue and create a task force to help build a solution to this mental health crisis.

Patrick Ellis, Executive Director of Chamberlains Children Center, spoke in regards to the relationships he has with the staff of Behavioral Health and the staff at Health and Human Services. He said that they are doing their absolute best, but the message that keeps being repeated is that they do not have the staff to accomplish what is going on in this Community. He asked that they take these statements very seriously and that we rally as a community to support the folks that are already stretched really thin doing this work.

Richard Perez Sr., Community Action Board Chairman, said that it is very important to pay attention of these issues that have been mentioned and try to find a solution. He spoke about how they are working on getting a youth center or a new public library which would make a huge impact in the lives of our youth. He said that he feels that there is a dis-function between the City and the County and that we need to work together to try and solve some of these problems. We have a huge disconnect between the Community and the Leaders in our Community. He said that he is trying to bridge that gap. He said that it effects everyone in the Community not just the youth. Chairman Anthony Botelho thanked everyone for taking the time to express themselves.

e. Department Head Announcements: Information Only

Joe Paul Gonzalez, spoke in regards to Elections. Said that as of yesterday they have surpassed 30,000 voters. He said out of the 30,000 voters 74% are registered to vote by mail, 26% are specifically public pole voters. He said that as of yesterday 2,078 vote by mail ballots were turned in that have been issued.

He said that this Saturday and Sunday they will have two sessions of poll worker training. He said that early voting has begun from 8:00 a.m. to 5:00 p.m. at the Elections Office. The weekend voting will be on November 3rd and 4th from 9:00 a.m. to 3:00 p.m., the weekend before the election.

He said that they are looking for backup workers for Election night and if someone is interested to call the Elections Office at 636-4016.

CAO Ray Espinosa said that out of the Internal Services Department spoke about political activity. He reminded the employees and the Board that political activities should be kept out of the workplace per state law and this memo has been sent out to all of the county employees and that it is a county policy.

CAO Ray Espinosa on behalf of the Clerk of the Board reminded the Board of Supervisors of the Assessment Appeal hearings that will take place on Monday, November 19th at 9:00 a.m.

Receive update from Lobbyist, Kim Stone, and advise the Board of Supervisors on topics of interest to San Benito County. SBC FILE NUMBER: 119

CAO Ray Espinosa invited Kim Stone our Lobbyist in Sacramento to provide an update.

Ms. Stone said that she was happy to be here. She provided an update as to what they have been doing in Sacramento and provided some information in regards to some bills that have become law this year that will effect the County.

She provided a PowerPoint presentation which covered the following: California Overview; Democratic Super Majorities; Becoming increasing Democratic as time goes on; Governor Browns last term; Expect Gavin Newsom; Key Ares of Differences; San Benito County's State Engagement; Bills SB901, SB1260, SB1343, SB1393. She provided a handout in regards to other new bills and laws and the Cannabis bills for the Board's review. She asked if the Board had any questions.

Supervisor Robert Rivas thanked Ms. Stone for her update. He mentioned the following AB1771(Bloom) related to Planning and zoning and regional housing needs assessment; SB 828 (Wiener) Land use housing element those are two important housing bills that effect our County. He said that maybe we can get Mary Gilbert from COG to attend our next meeting to give us an update on the housing.

CAO Ray Espinosa said that a portion of that comes from our RMA office so I will see if they both can work together.

Supervisor Mark Medina thanked her for the update. He said that you have been with us 10 months now what have you brought to the County or what are you working on now that will bring

us dollars to the bottom line here.

Ms. Stone said that the place they tried to bring additional money was the homeless services, which was about 2 to 4 million dollars, we did not succeed in getting that and now legislative is in recess. She said what we need to do in finding money for the County is figure out now what sort of specific asks we want in detail and go early so we can get it in the budget process.

She said that she can come back after the election to give an update on some of the bills that passed.

Chairman Botelho asked if there was any public comment.

Those speaking from the public was: Elia Salinas, thanked Ms. Stone for coming. She mentioned that she is critical in the fact that \$150,000 is being spent on this consultant in Sacramento and what has she done for the County. She said it is disappointing to hear that they were late in trying to get funds for the shelter. She said that we do need funds for fire, safety as well mental health issues.

Chairman Botelho said that this is on going work and we do need regional cooperation.

18. HEALTH AND HUMAN SERVICES AGENCY - J. RYDINGSWORD

Receive presentation by Dr. Gail Newel, Public Health Officer, re update of the San Benito County Opioid Task Force and launch of its website in its continued efforts to respond to opioid use and misuse impacting our community.

Health and Human Services Director Jim Rydingsword provided information in regards to the opioid task force and said that they are here to give an update and give them information on the website they are launching today.

He also mentioned that after they were done today they could go down and get their Flu Shot at the Veteran's Center.

Dr. Gail Newel provided an update on their 1 year anniversary of the San Benito County Opioid Task Force program. She said that they applied for a grant for the opioid safety network and were approved, which will help provide expert coaching and assistance and networking opportunities and has also funded a AmericCorps volunteer to join our task force and work with our County agencies. She said that they have developed a website which they will see today and they are launching with the help of Veronica Johnson and the IT Department.

She introduced Veronica Johnson AmeriCorps (VISTA) Volunteer through the Opioid Task Force who introduce the website. She gave a quick overview of the site which she published live at the end of the presentation.

Mr. Rydingsword thanked the Board for their support.

19. COUNTY ADMINISTRATIVE OFFICE - R ESPINOSA

Receive Fiscal Year End 17/18 Budget Review and FY 18/19 1st Quarter Update.

Finance Officers Melinda Casillas and Stewart Patri provided information in regards to the Fiscal Year End update and a PowerPoint presentation which covered the following: CAO Budget & fiscal Report; General Fund as of 6/30/18; Extraordinary Items; Economic Indicators; Road Revenues; Attachments-Exhibits; General Fund; General Fund Salary & Benefit Details; County-Wide Salary & Benefits Expenditures; Contingencies as of 10/10/18; Adopted Budget FY 2018-19 which is now available on the County website.

CAO Ray Espinosa said that overall I think it was a decent budget we have a lot of vacancies. He said that staffing has been an ongoing concern, he said that there are some things that we need to look at. He mentioned that one of the things that was up was sales tax.

20. RESOURCE MANAGEMENT AGENCY- J. GUERTIN

Receive an update regarding safety concerns for the intersection of Fairview Road and Fallon Road; and provide direction to staff.

CAO Ray Espinosa mentioned that Supervisor's Medina and Rivas both asked for this item to be agendized to get a report from the RMA office on this.

RMA Director John Guertin provided information in regards to the safety of the intersection of Fallon and Fairview and some data that has been provided to him from the Highway Patrol in regards to accidents at that intersection (9 with 2 being fatalities) which was compared to other intersections in the County.

He provided some of the issues with that intersection as to how it doesn't T up for a signal and how maybe the best option would be to T up the intersection but there is issues of private property. He mentioned getting a traffic study to come up with some options to address this intersection.

Chairman Anthony Botelho asked if there was older studies that addressed those intersections in regards to mitigation requirements.

Supervisor Mark Medina asked if the stop light that was figured for Sunnyslope and Fairview could be done at Fairview and Fallon instead.

Mr. Guertin replied, no because the light at Sunnyslope and Fairview was part of the litigation agreement of the Santana Ranch Development.

He provided an estimate of costs for construction of improving the road and Teeing up the intersection about \$500,000; \$300,000 to install the traffic signals; \$400,000 for the design work; \$300,000 right of way; \$200,000 for contingencies, for a total of about 1.5 million to 2 million. He said that this is something that we would be looking for grants for which we have applied for the last couple years and have been denied because there are not enough fatal accidents to qualify. He said that the fortunate thing was they provided this project in the Measure G proposal, so if Measure G does pass this is one of the priority projects to get done under that funding.

Supervisor Jerry Muenzer asked if it would cost more to do a round a bout than T up the intersection and do a signal.

Mr. Guertin replied a round a bout usually costs more because it requires more acquisition right of way. He said with this intersection that may not be an issue it would be something that they would need to look at. He said that this intersection was good candidate to explore a round a bout. Chairman Botelho opened public comment.

Those speaking from the public were: Tim Foley, Hollister resident, spoke in regards to the tragedy on Fairview Road with the buses, trucks, etc. Was glad to hear that there is a concrete process unfolding. He asked what we could do in the meantime while this is in process, maybe put up a flashing light or something that would help save some lives.

Nants Foley, Hollister resident, spoke about Fallon Road and Fairview Road being an insane Road to drive on. She said that we need to look at the whole road and we need to slow down traffic. We are looking at tragedy after tragedy happening there. She said that anything that would be done to help that intersection would be greatly appreciated by everyone that drives it. She thanked the

Board for their time and effort.

Melissa Michaelson, Hollister resident, spoke about how unsafe the intersection is at Fallon and Fairview Road and how she had a pretty horrific accident at that intersection. She spoke of the volume of traffic on that road due to more housing developments, etc. She said it saddened her to hear that we have to have more fatalities in order to try and get things done. She said I don't want our kids to be a statistic.

Chairman Botelho said our roads need of a lot of thought and time, traffic goes way to fast on the roads and we need to find a way to slow people down.

Supervisor Robert Rivas thanked staff for bringing this presentation forward. He said that he feels that this intersection needs serious attention. He said that he hopes that we can take some action to get this intersection done soon. Thanked Mr. Guertin for his report.

Mr. Guertin said as far as a permanent solution right now I think we will wait a few weeks to see if Measure G passes and then we can go from there. He said they would look into temporary measures to slow down traffic. He said that he would be back at the November 20th meeting with an update.
