# A. RESOURCE MANAGEMENT AGENCY

Update on proposed restoration of the Tres Pinos Creek at the San Benito County Historical and Recreation Park.

Commissioner Don Pidd said that all he knows is that they have hired some engineers to work with FEMA to try and keep the channel where it was or move it back to where it was two years ago.

# C. PARKS AND RECREATION COMMISSION

Discuss plans to update the San Benito County Parks and Recreation Facilities Master Plan per recommendations of the Parks and Recreation Ad Hoc Committee.

Commissioner Don Pidd mentioned that they would hear from the Ad hoc committee which consists of Commissioner's Paul Hain and Mindy Sotelo. He invited new Commissioner Marie Peterson to replace Commissioner Foley on the Ad hoc committee.

Commissioner Paul Hain said that they met with Don Kelley who was one of the original members of the Parks & Recreation Commission. He said that they got some background information from him in regards to the Parks & Recreation.

Commissioner Sotelo said that it was a very informative meeting with Don Kelley. She said that maybe some of the things that they could work on in the future would be to reach out to the City of Hollister Parks & Recreation commission and try to work together and work with county staff and Supervisors. She said that after meeting with him I feel that this is doable.

She said that a few of the things that they would like to see done was to get a completion list from RMA of all of the completed items out of the master plan; Park impact fees-amount in fund and the expenditures over the last three years; Designated staff person with the County to work with; Copy

of the Regional Park Plan and to maybe have a Commission workshop to go over everything to talk about what they want to do and move forward.

Commissioner Pidd mentioned that maybe have RMA Director John Guertin contract Commissioner Sotelo in regards to the master plan.

Commissioner Sotelo suggested maybe having a community meeting after they have got their ducks in a row. She said at that time we need to make sure our website is up and working.

Commissioner Pidd said that we need to have a clear way to get the community involved. He talked about having a retreat or workshop off site, it would be a special meeting.

Discussion ensued by the Commissioners in regards to having a retreat possibly in October.

Commissioner Pidd said that they would work on the September meeting to get items from RMA that they need for the master plan and possibly schedule a retreat for October. He provided the process that it would have to go through in order to complete.

Commissioner Sotelo asked if there was a deadline for the master plan.

Commissioner Pidd replied hopefully by next years budget period.

Discussion ensued by Commissioners.

Commissioner Sotelo said that she would reach out to John Guertin instead of him trying to contract her.

Commissioner Pidd asked the Commissioners to reach out to their supervisor to keep them aware what the Parks & Recreation Commission is doing and would like to do.
