**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BENITO AUTHORIZING THE RELEASE AND TRANSFER OF UNCLAIMED CHECKS FROM THEIR RESPECTIVE SPECIAL FUNDS TO THE COUNTY GENERAL FUND PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTIONS 50050 AND 50053.**

***WHEREAS***, in accordance with Section 50050 of the California Government Code, unclaimed checks, excluding those representing restitution collected on behalf of victims, become County property after three (3) years following publication of public notice in accordance with Section 50051 of the California Government Code; and

***WHEREAS***, each of the unclaimed checks listed in Exhibit A, attached hereto and incorporated herein, has been outstanding and unclaimed in special funds for more than three (3) years; and

***WHEREAS***, in accordance with California Government Code Sections 50050 and 50051, the County provided the required public notice; and

***WHEREAS***, none of the unclaimed checks listed in Exhibit A represent restitution collected on behalf of victims which shall be deposited into the Restitution Fund; and

***WHEREAS***, the total amount of the unclaimed checks, excluding restitution to victims, is \$28,650.28; and

***WHEREAS***, pursuant to California Government Code Section 50053, when the unclaimed checks become County property, the Board of Supervisors may transfer it to the County General Fund.

***NOW, THEREFORE, BE IT RESOLVED***, by the Board of Supervisors of the County of San Benito that, in accordance with California Government Code Sections 50050 and 50053, the unclaimed checks listed in Exhibit A in the total amount of \$28,650.28 shall be transferred from the respective special funds to the County General Fund or other designated fund(s).


