A RESOLUTION OF THE SAN BENITO COUNTY BOARD OF SUPERVISORS. ACCEPTING THE 2019 COMMUNITY SERVICES BLOCK GRANT AND APPROVING STANDARD AGREEMENT #19F-4034 WITH THE STATE OF CALIFORNIA DEPARTMENT OF COMMUNITY SERVICES AND DEVELOPMENT FOR \$267,930 FOR THE TERM OF JANUARY 1, 2019 THROUGH DECEMBER 1, 2019

WHEREAS, the State of California Department of Community Services & Development (CSD) has made Community Services Block Grant (CSBG) funds available to the County of San Benito for 2019 to administer and/or operate community-based programs designed to reduce poverty; revitalize low-income communities, and empower low-income families and individuals within the County; and

WHEREAS, CSD has offered Standard Agreement #19F-4034 in the amount of \$267,930.00 for the term of January 1, 2019 to December 31, 2019 to the San Benito County Health and Human Services Agency. Department of Community Services & Workforce Development; and upon acceptance of said Agreement the County certifies that all uses of funds will be in compliance with CSD regulations, guidelines, and grant provisions: and

WHEREAS, the San Benito County Board of Supervisors has determined that there is a need for antipoverty programs and has designated the Health and Human Services Agency-Community Services Workforce Development (HHSA-CSWD) as the Agency to administer programs on behalf of the County that benefit lowincome populations

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of San Benito hereby:

- 1. Accepts the 2019 CSBG grant in the amount of \$267,930.00; and
- 2. Approves Standard Agreement #19F-4034) with the State of California Department of Community Services & Development for the term of January 1, 2019 to December 31, 2019; and
- 3. Authorizes the HHSA Director or Deputy Director to execute Agreement #19F-4034 and take all actions necessary to administer the grant, including entering into and signing the grant agreement. any amendments to the grant agreement, and other documents related to the grant subject to review by County Counsel.
