ADDENDUM TO THE SAN BENITO COUNTY DEVELOPMENT IMPACT FEE REPORT FISCAL YEAR ENDED JUNE 30, 2018 & FIVE YEAR FISCAL YEARS 2013/14 - 2017/18

The following modifications and additions to the Report should be made as described:

- 1. The phrase "Road Equipment Impact Fee" should read "Road Maintenance Impact Fee" in the Table of Contents and on pages 4, 13, 14, and 15 to reflect the change in the name of the fee.
- 2. The phrase "Fire Protection Impact Fee" should read "Fire Mitigation Impact Fee" in the Table of Contents and on pages 4, 17, 18, and 19.
- 3. The phrases "Criminal Justice Facilities Impact Fee" and/or "Jail and Juvenile Hall Impact Fee" on pages 4, 23, 24 and 25 will be changed to "Detention Facilities Impact Fee" to reflect the change in the name of the fee.
- 4. The two paragraphs directly below the sub-heading "Purpose/Reasonable Relationship" on page 23 are replaced in their entirety to read as follows:

"The Detention Facilities Impact Fee was added to the San Benito County Code in 2018 to impose development impact fees to fund the cost of detention facilities, the need for which is generated by new development within the County. There is a reasonable relationship between the use of the proceeds from the Detention Facilities Impact Fee and the new development upon which it is imposed because the proceeds fund only the portion of the program or project costs attributable to new development."

- 5. Paragraph "D" of "Note #3 Additional Impact Fees" on page 32 should be deleted in its entirety.
- 6. The loan principle amount of \$1,467,000 in "Note #1 Additional Impact Fees" on page 32 is revised to read \$995,500, and the following language shall be added to the end of the paragraph. "The loan was approved by the Board of Supervisors on 12/09/2014 pursuant to Resolution No. 2014 107."
- 7. Add to the report the Building Impact Fee Summary effective as of December 20, 2018, attached hereto.
- 8. A note shall be added to each impact fee fund State of Revenues and Expenditures stating the following:

"The phrase "transfers out" indicates a reimbursement from the development impact fee fund to the General Fund and/or the Capital Improvement Fund that initially funded the purchase or project." 9. A note shall be added to page 18 under the Fire Mitigation Impact Fee Five Year Statement of Revenues and Expenditures table stating the following:

"In FY 2017/18 a receivable was recorded in the amount of \$34,250 (referenced in Note #1 of page 6 as accrued reimbursement revenue) to recognize the agreement between the County and the City of Hollister and San Juan Bautista to each pay their proportionate share of the Fire Feasibility study."

10. The "Completed Projects" tables for the Traffic Impact Fee, Road Maintenance Impact Fee, Fire Mitigation Impact Fee, and Parks and Recreation Impact Fee sections found on pages 11, 15, 18, and 30, respectively, are revised to read as follows:
