# **BOARD OF SUPERVISORS**

Present the outgoing Chair of the Board of Supervisors, Anthony Botelho, with a plaque of appreciation for his term as Chair of the Board of Supervisors for 2018.

Vice Chair Jerry Muenzer presented Chairman Anthony Botelho with a plague from the Board for his year as Chairman of the Board of Supervisors.

Chairman Botelho thanked the people of San Benito County for the privilege of serving as a County Supervisor. He thanked all of the dedicated County Employees; Department Heads,

Elected Department Heads, County Clerk, County Counsel and CAO Espinosa. He thanked Supervisor Rivas, Supervisor Medina, Supervisor De La Cruz and Supervisor Muenzer. He said that nothing gets done unless with all work as a team for the betterment of the entire County. He said to Supervisor Muenzer that it had been a pleasure working with you as you have proven to be a tireless leader working on many of the County projects and committees, a regional leader being Chairman of Ambag and Monterey Bay Pollution Control Board and Mobility Partnership. Thank you for your leadership in the Homeless program, Cleaning up Southside Hospital, improving fire protection and many other accomplishments. Good luck to you and Carol, He said that I am very proud of the accomplishments of San Benito County in 2018. He went over a few highlights: The Board made a commitment to improve revenue by placing a number of taxes on the ballot. In June the County was successful with Measure C the Cannabis Tax, the revenue from this will help improve public safety as we get deputies on the street and improve more services; successful with Measure B raising the transient Occupancy Tax from 8% to 12%, the revenue from this source will improve the County's commitment to economic development; in November the County had Measure H which established a business license requirement in the unincorporated areas of the County, not only will this assist the County with zoning compliance and enforcement it will provide revenue for road maintenance and other services. He said that the big win was Measure G a 1% sales tax to widen Highway 25 and maintain our roads. He said that this will also open the door for additional leverage funding from the State in that San Benito County is now a self help County. This will add millions of dollars to our roads that we did not have before. In 2018 the County reviewed and updated its fee structure to make sure we have cost recovery for services that we provide. We also established Community Finance Districts on new developments to recover on going impacts that occur with growth. For economic development the County is in the process of implementing zoning changes in the commercial nodes on the 101 corridor that will attract business, create jobs and improve tax revenue. Besides enhancing our future revenue for San Benito County that will be enjoyed for years to come the County has accomplished a number of big projects. He said that the ones I am most proud of are the multi agency agreements such as the opening of Nash Road between the San Benito High School and the City of Hollister working together to improve safety to the High School and opened up future development of the County Regional Park. The City of San Juan Bautista, Hollister and the County entered into a contract with Recology for waste pickup. The parties also agreed to a fire protection contract. We also entered into a contract for energy services with Engie which will include new energy efficient lighting and development of solar on County properties the cost is over 8 million dollars financed through the savings generated from the energy savings. It is projected that the County will realize 11 million in net savings over the 30 year life span of this project. This will reduce County energy costs by

He said looking forward the jail project should be completed next year and to date RMA needs to be commended in keeping this project on time and within budget. RMA and John Guertin got the bridge projects back on track and construction on a number of bridges should begin soon. He said in today's meeting we will most likely approve a cannabis ordinance and moving forward in awarding contracts for our new Behavioral Health building with construction beginning this spring. We also hope to complete next year a new contract with Waste Connection for the John Smith Landfill.

He said that Jim Rydingsword and his team has done a great job in making the difference in lives of some of our homeless citizens. We are seeing dividends in his efforts and other Counties want to copy what San Benito County is doing today.

He said in closing and as a Supervisor that has been around for awhile I have not been more optimistic for San Benito County's future. He said that he looks forward to working with the new members of the Board, Supervisor Elect Jim Gillio and Supervisor Elect Peter Hernandez and continuing working with Supervisors Medina and De La Cruz to meet the challenges we will undoutable face in 2019. He said thank you and Happy Holiday's.

and has spent many long hours working on many different things particularly the County budget and has done a fantastic job. He presented her with a Certificate of Recognition and congratulated her on her new venture as the new Treasurer/Tax Collector.

Melinda Casillas thanked the Board and Ray Espinosa and said that it has been a wonderful opportunity and is excited to move on in her new position. She said she appreciated working with everyone and thanked Ray for all of is help but she was not going far.

First 5 Director Lisa Faulkner provided a PowerPoint presentation in regards to their Strategic Plan 2018-2022. She said that every four years they are required to look at their strategic plan.

She said that she was here to highlight what is new and some background about what they have invested in over the past and why they have developed new strategies and plan.

She said one of the biggest investments over the past 5 years has been in their Family Wellness program which she explained what it is about. She spoke of some other key investment programs such as their Literacy program and infrastructure as an independence entity, She said in 2015 they became independent from San Benito County. She said that they are looking forward to the new plan and meeting with the Board individually to continue to gather in put on phases of the new plan.

She said that the biggest change for First 5 is focusing on entire families and looking into a Impact Center to create a trauma-informed Children, Youth & Families center that demonstrates the effectiveness of therapeutic approaches within an early education and intervention program for children and families who have experienced trauma and adversity. The center is planned to be at the old Fortino building by the YMCA and plans to bring this back at a later date for input.

Supervisor Mark Medina said that he sits on the commission and that they do great things for this community and supports it 100%.

Supervisor Jaime De La Cruz said that he has a question for legal counsel as to why we are hearing this presentation since they asked to be severed ties from the County.

County Counsel Barbara Thompson said that they are still obligated by the MOU to present documents to the Board periodically on an annual basis even though they are technically separate and apart and we still appoint the First 5 commission.

Discussion ensued by Board, staff and Ms. Faulkner.

Chairman Botelho thanked Ms. Faulkner for the report.

Auditor Controller Joe Paul Gonzalez said that they are doing a PowerPoint presentation to show how the November 6th election went and explain how their new voter system worked.

Angela Curro, Assistant Clerk/Recorder, provided the details: San Benito County Historical Voter Turnout by Election-Vote by Mail-Polling Place-Early vote; San Benito County Historical Registrations Processed by Year-going back to 1990; Some of our Challenges for 2018; Thanked the Volunteers.

Ms Curro said that we have some good news, we have some grant funding coming from (HAVA) Help America Vote Act which is for accessible polling place and ADA to access to voting. We have a current grant of \$10,000.00 and two additional grants coming from the federal government for \$20,000.00. In addition the State of California has granted \$348,500.00 to San Benito County for matching funds towards a new voting system and that includes previous purchase new voting systems. So we can get some money back for what we have already paid.

She spoke about preparing for the March 2020 primary and post election processing and that they are going to Sacramento for a new law workshop for new legislation in place for 2019 & 2020. She said that they will be preparing for the 2020 census.

Supervisor Mark Medina thanked them for an excellent job.

RMA Director John Guertin provided information regarding CSA's. He said that they had been directed by the Board to come back with a report on the CSA program. He said that they had filled the CSA Coordinator position with Jessica Stratton and was able to get help from Precision Engineering to help with the report. He said that they have a high level collection to date on the CSA;s.

Chairman Anthony Botelho said that we need to improve going forward. He said that he is encouraged by the analysis and recommendations from the presentation.

Mr. Guertin summed up by saying there is a number of issues that they are trying to address and mentioned some of the things that they have done like mowing and drain improvements. He said that some of the things that they will be working on is getting direction from the Board to proceed with the inactive CSA's through LAFCO and working with Precision to develop an engineers estimate and engineers plan for capital improvement so that the folks in the CSA's have a annual perspective and expectation of services on an annual basis, There are a lot of issues that have been hanging out there for a long time and we need to work better together to resolve that.

Chairman Botelho said that the CSA;s do deserve the services. Chairman Botelho opened the public comment period.

Those speaking from the public were: Richard Ferreira representing 22 property owners in Union Heights CSA 35. He spoke in regards to storm drainage maintenance, road maintenance, CSA 35 history, current RMA, finances, CSA 35 being funded by property owners, established boundaries and tasks.

Chuck Serafini spoke in regards to Union Heights dedications and portion of Union Heights Drive being a county road, being taxed on drainage and the road supposed to be slurred every 5 years and being faced with additional expense because a road is deteriorating.

Jack Murphy, CSA #9, spoke in regards to report given by Percision today and the road maintenance.

Stephen Mills, CSA #9 Vice-President of Ridgemark Bluffs, spoke in regards to road maintenance inside the gates and \$600,000 sitting in a fund at the County they have paid into and being billed for road maintenance and being told that they can't do road maintenance that it is a Board's decision. Would like the Board to take action to resolve this problem.

Chairman Botelho closed the public comment period and brought it back to the Board for discussion.

Chairman Botelho said that we need to state what our next steps are as to how we are going to resolve this. He said that the comments are very valid and we need to take some action and move forward.

Supervisor Mark Medina said that dissolving inactive CSA's should be a no brainier. He said as far as providing services per the agreement for each CSA, we need to be held accountable and provide the services. He said in regards to gated communities he does not agree to taking them down, he

said that if they paid in to a fund then they should be able to do the road maintenance. It is not public funds it came from their tax. He said that we need to work forward with a plan.

Supervisor Jerry Muenzer thanked John Guertin and Percision for the report. He said that it is a good first step but more steps are needed. He said that he agrees with dissolving inactive CSA's but need to reach out to them in regards to dissolving them.

Supervisor Jaime De La Cruz thanked staff for their presentation and the public for their comments. He said that we need to move forward.

Chairman Botelho spoke about his frustration how things never got done with prior staff. He said that we have to get this right. He said that John Guertin is doing his best for what he has right now. He said that we need to work on our communication skills countywide and give him a chance to straighten this mess out. He said that we have an obligation if we collected for road maintenance and that he supports this program.

John Guertin said on the issue of gates we are trying to find solutions like every body else. He spoke about the implementation schedule in order to get it up to date and support from everyone to try and make progress.

Supervisor De La Cruz said that he would like for them to come back to the Board on a monthly basis with information including current staff time.

Mr. Guertin agreed that they could do that.

Chairman Botelho said that was a good suggestion. He thanked Percision for their report.

Tim Cromartie of HDL provided a PowerPoint presentation in regards to the Regulatory Provisions Process which included: Overview: Proposed Regulatory Ordinance; Cannabis Business Regulatory Program; Application Evaluation Process; Cannabis Business Permits; Cannabis Employee Work Permit; Cannabis Permit Application Process; Questions.

Sheriff Darren Thompson provided some brief thoughts in regards to safety impacts and the resolution adopted today. He said that the success of this industry is going to be contingent upon the consumer base, some of those consumers will become impaired and choose to get behind a wheel of an automobile. The key to the success of this permitted industry will be partly contingent upon our ability to dismantle the non permitted industry, to provide oversight to the permitted industry and conduct effective enforcement of the non permitted industry. To keep our community safe from impaired drivers, etc. my office is going to need more staff and that staff is going to need more training. The voters have the role of determining the politics but you have the role of determining the policy. If you commit to this policy today I would hope that you would also commit to supply the staff necessary to make this ordinance successful and keep our community safe. I heard a conversation a few minutes ago from our CAO that we will be returning January to talk about our finances and at that time it would be great if we could talk about the cost to have additional staffing to make sure that this new program is a success and make sure that we can keep our community safe.

Chairman Botelho said as one Supervisor he heard that message loud and clear and would hope that if we do move forward with this ordinance and this industry that we are going to be able to provide additional public safety.

Supervisor Jaime De La Cruz thanked the Sheriff for his opinion and information. He said that they will help to support his department.

County Counsel Sarah Dickenson said that some copies have been put in the back of the room of the updates of the ordinance and the Planning Commission Resolution.

Chairman Botelho opened the public hearing.

Those speaking from the public were: Jim Keener of San Juan Bautista spoke in regards to the county needing tax money and in door and out door grows.

Pete Brazil, Attorney for JRG representing several clients, thanked the Board, staff, community and HDL for developing and producing the ordinances that we now have before us. He said that this is a good start, good place to begin this business in the County. He spoke about the permit limits in the ordinance and having a flexibility. He said that he supports the ordinance.

Jack Kirk, Community, had a couple of questions about outside grows, protecting the 5 and 10 acre home sites and the County budget to front money to invest in this.

Chairman Botelho closed the public comment.

Discussion ensued by Board and staff.

County Counsel Sarah Dickenson provided information on questions that the public had in regards to out door grow and 5-10 acres.

She said that there are no out door grows for commercial or personal.

Set back requirements stated in section 19.43.071 indicates if on 10 acres or less the business should be 300 feet set back. Set backs do not apply in the industrial zone.
