11.09 OF THE SAN BENITO COUNTY CODE**

NOTICE IS HEREBY GIVEN that the San Benito County Board of Supervisors will hold a public hearing on Tuesday, February 05, 2019, commencing at 9:00 a.m., or as soon thereafter as possible, in the Board of Supervisors Board Room, Administrative Building, 481 Fourth St., 1st Floor, Hollister, CA to consider and potentially adopt an ordinance regulating ambulance service in San Benito County by amending Chapter 11.09 of the San Benito County Code, as follows.

Add permit, Certificate of Operation, and staffing requirements for Gurney Vans and Wheelchair Vans owned and operated within the County. (See Sections 11.09.007 and 11.09.020.) Strike provision related to notifying City Managers of application submission. Update citation. Add requirement for permittee to maintain current data with EMS Agency. Remove provisions for existing ambulance companies. (See Section 11.09.008.) Modify the provisions related to payment of fees; Require invoice evidencing fees to be paid. Remove proration of fee. Remove provision relating to penalty fee for late applications. (See Sections 11.09.008, 11.09.010 and 11.09.011.) Update time periods. Remove time period for notice to discontinue service. Update criteria for issuance of Certificate of Operation. (See Sections 11.09.009 and 11.09.011.) Require fee instead be paid upon receipt of invoice. (See Section 11.09.012.) Minor verbiage updates. (See Sections 11.09.017, 11.09.019, 11.09.021, 11.09.027, 11.09.041, and 11.09.045.) Remove effective date provision. (See Section 11.09.050.)

Verbal and written comments may also be submitted at the public hearing. A complete, certified copy of the proposed ordinance is on file in the Clerk of the Board's Office and it shall be available for public inspection and review during normal business hours at that location.
