RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BENITO, STATE OF CALIFORNIA, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE AGREEMENT NO. 18G26135 TO PROVIDE THE COUNTY WITH REIMBURSEMENT TO COMPLY WITH SECTION 251 OF THE HELP AMERICA VOTE ACT OF 2002 (HAVA POLLING PLACE ACCESSIBILITY TRAINING PROGRAM), AND AUTHORIZING THE COUNTY CLERK-AUDITOR-RECORDER & EX-OFFICIO REGISTRAR OF VOTERS, OR DESIGNEE, TO CONDUCT ALL NEGOTIATIONS, EXECUTE AND SUBMIT ALL DOCUMENTS INCLUDING, BUT NOT LIMITED TO, PAYMENT REQUESTS FOR REIMBURSEMENT OF HAVA FEDERAL FUNDS AUTHORIZED EXPENDITURES

WHEREAS, the Help America Vote Act of 2002 has been enacted to improve election administration and to provide Counties with federal funds to assist in complying with the requirements of the Help America Vote Act of 2002 ("HAVA"); and

**WHEREAS,** the purpose of this agreement would be to assist the County of San Benito in implementing HAVA Section 251, known as the HAVA Polling Place Accessibility Training Program; and

**WHEREAS,** by executing proposed Agreement No. 18G26146 with the Secretary of State, the County may receive a maximum grant amount of \$10,000.00 for participating in activities outlined in Agreement No. 18G26146.

**NOW, THEREFORE, BE IT RESOLVED** that the San Benito County Board of Supervisors hereby:

- 1. Approves the execution of an agreement between the County of San Benito and the Secretary of State to receive HAVA Section 251 grant funds; and
- 2. Authorizes the Chair of the Board of Supervisors execute Agreement No. 18G26146; and
- 3. Authorizes the Clerk-Auditor-Recorder & Ex-Officio Registrar of Voters, or their designee, to conduct all negotiations, execute and submit all documents including, but not limited to, payment requests for reimbursement of HAVA Section 251 authorized expenditures.
