## **SUMMARY OF ORDINANCE**

The development agreement is required to be approved by ordinance. The ordinance includes as attachment 1, the description of the project site, and as attachment no 2, the proposed development agreement. Pursuant to Article 4 of the Agreement, Pacific Bay agrees to pay County "Community Benefits" which will benefit the County as contemplated by the Development Agreement Ordinance, including payment of 1% of Gross Receipts received at the project site. The Development Agreement will also provide vested rights to the Applicant to operate hemp activities on site as specified in the Development Agreement. Section 2 of the ordinance contains findings related to CEQA and sets forth the required development agreement findings. Section 3 contains the general provisions related to the ordinance (Severability, Captions, Codification, Effective Date, and "No duty of Care" preventing a basis for civil liability except as otherwise imposed by law.
