Article III of Chapter 25.29 of the San Benito County Code.
APPLICANT: San Benito County LOCATION: San Benito County, CA (County-wide in unincorporated areas.) On January 15, 2020 the Planning Commission (PC) Adopted PC Resolution 2020 01 (4-0 vote), recommending that the Board approve an amendment to Chapter 25.29 of the San Benito County Code (the County's Sign Ordinance). The sign ordinance would be amended throughout. This includes but is not limited to changes relating to size of signs, number of signs, political signs, temporary signs, enforcement of signs, and zoning for signs. ENVIRONMENTAL REVIEW: Not a Project and/or Exempt.
