The CITY OF HOLLISTER/ SAN BENITO COUNTY received grant funds from the EDA totaling \$300,000 in 1996 which we used to build our San Benito Loan Fund. This fund was established with the purpose of assisting the communities in the San Benito County area affected by the downturn. In the past several years these funds have been significantly underutilized; we have had budget and staff reductions resulting in the program being in sequestration for many years. Our goal is to ensure this program is fully optimized by assisting businesses across the County with operational funding to help them grow, create jobs, and generate private investment.

RESOLUTION NO. 2014 - 108

A RESOLUTION OF THE SAN BENITO COUNTY BOARD OF SUPERVISORS APPROVING TRANSFER OF REVOLVING LOAN FUNDS

WHEREAS, the Economic Development Administration (EDA) awarded a grant in the amount of \$300,000 to the City of Hollister and San Benito County in June 1992 and the City of Hollister and San Benito County matched \$200,000 to establish a Revolving Loan Fund (RLF) which has operated under the provisions of an EDA approved RLF Plan that has been periodically revised; and,

WHEREAS, on June 26, 1992 EDA awarded a \$300,000 grant to the City of Hollister and San Benito County to establish an EDA RLF to service the communities of San Benito County; and,

WHEREAS, the City of Hollister with San Benito County's concurrent approval wishes to relinquish custody of the Economic Development Administration Revolving Loan Fund to Fresno Community Development Financial Institution; and,

WHEREAS, Fresno Community Development Financial Institution wishes to gain custody of the remaining balance of approximately \$686,878 and has agreed to accept all funds and all financial information related to the Economic Development Administration Revolving Loan Fund; and,

WHEREAS, Fresno Community Development Financial Institution must formally accept the City of Hollister and San Benito County grant from EDA to continue the use of the RLF capital associated with the grant in the San Benito County area; and,

WHEREAS, Fresno Community Development Financial Institution must update its EDA Revolving Loan Fund Plan to comply with EDA regulations and to incorporate the City of Hollister and San Benito County RLF grant assets into its existing RLF capital base.

NOW THEREFORE BE IT RESOLVED by the San Benito County Board of Supervisors that:

- 1. San Benito County/City of Hollister shall transfer the sum of \$686,878 in the Economic Development Administration Revolving Loan Fund to the Fresno Community Development Financial Institution.
- 2. San Benito County/City of Hollister shall deliver all funds and all financial information related to the Economic Development Administration Revolving Loan Fund.
- 3. As of December 31, 2014, the Fresno Community Development Financial Institution will gain full custody of the City of Hollister and San Benito County Economic Development Revolving Loan fund from City of Hollister and San Benito County, and use it to issue loans with San Benito County.

- 4. As of December 31, 2014, the Fresno Community Development Financial Institution will have sole responsibility for the City of Hollister and San Benito County Economic Development Revolving Loan Fund, and all requirements therefore associated with it.
- 5. The County Administrative Officer shall be authorized to take all actions necessary to effectuate the transfer of funds prior to December 31, 2014, and the County Administrative Officer is further authorized to execute an agreement with Fresno Community Development Financial Institution to memorialize the agreement between the parties regarding the transfer of funds.
