2 A RESOLUTION APPROVING AND AUTHORIZING SUBMISSION OF A 2020
3 APPLICATION FOR FUNDING FROM THE GENERAL/COLONIA ALLOCATION OF
4 THE STATE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM,
5 AND AUTHORIZING THE HEALTH AND HUMAN SERVICES AGENCY DIRECTOR
6 OR DEPUTY DIRECTOR TO ACCEPT THE GRANT, IF AWARDED, AND ENTER INTO
7 AND EXECUTE THE GRANT AGREEMENT, ANY AMENDMENTS, AND OTHER
8 DOCUMENTS NECESSARY FOR PURPOSES OF ADMINISTERING THE GRANT

9 WHEREAS, the San Benito County Board of Supervisors has reviewed an application for funding
10 of up to \$3,500,000 from the General/Colonia allocation of the State Community Development
11 Block Grant (CDBG) program for the following activities:

12 **a. Public Services- \$500,000:**

- 13 - \$187,500: Operations of Sun Street Center for a residential treatment facility
14 - \$275,000: Operations of Community Homeless Solutions year-round Homeless Shelter
15 - Approximately \$37,500 will go towards admin fees as allowed by the State (7.5%)

16 **b. Public Facilities:** \$3,000,000 for the construction of 8-10 Transitional Housing units for
17 homeless families and a community center within the area of transitional housing and
18 revitalizing of an existing park. Approximately \$225,000 will go towards activity delivery
19 fees as allowed by the State (7.5%).

20 WHEREAS, on May 19, 2020, the San Benito County Board of Supervisors held a duly noticed
21 public hearing regarding the 2020 CDBG application; and

22 WHEREAS, all persons present at the public hearing were given the opportunity to hear and be
23 heard regarding all matters properly before the Board of Supervisors.

24 NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of San
25 Benito hereby approves the submission of the 2020 CDBG application, and hereby authorizes and
26 directs the Health and Human Services Agency (HHSA) Director or Deputy Director to execute and
27 submit the application and act for and on behalf of the County of San Benito in all matters pertaining
28 to the application.

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of San Benito hereby
finds and determines that federal Citizen Participation requirements were met during the
development of the application.

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of San Benito hereby
authorizes the Health and Human Services Agency Director or Deputy Director to accept the grant,
if awarded, and to enter into and execute the grant agreement and any subsequent amendments with
the State of California, for and on behalf of the County of San Benito.

1 **BE IT FURTHER RESOLVED**, that the Board of Supervisors of the County of San Benito hereby
2 authorizes the Health and Human Services Agency Director or Deputy Director to execute Funds
3 Requests and other required reporting forms necessary for purposes of administering the grant, for
and on behalf of the County of San Benito.
