WHEREAS, the Board of Supervisors of the County of San Benito desires to submit a LEAP grant application package ("Application"), on the forms provided by the Department, for approval of grant funding for projects that assist in the preparation and adoption of planning documents and process improvements that accelerate housing production and facilitate compliance to implement the sixth cycle of the regional housing needs assessment (RHNA); and

WHEREAS, the Department issued a NOFA and Application on January 27, 2020, in the amount of \$119,040,000, to provide assistance to all California jurisdictions.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of San Benito that it hereby authorizes and directs the Resource Management Agency Director to apply for and submit an Application for the LEAP grant to the Department; and

BE IT FURTHER RESOLVED by the Board of Supervisors of the County of San Benito that if the Application is approved by the Department, the Resource Management Agency Director is hereby authorized to enter into, execute, and deliver a State of California Standard Agreement in the amount of \$65,000.00, as well as any and all other documents required or deemed necessary or appropriate to evidence and secure the LEAP grant and the County's obligations related thereto, and any and all amendments thereto, for and on behalf of the County of San Benito; and

BE IT FURTHER RESOLVED by the Board of Supervisors of the County of San Benito that it hereby agrees that the County shall be subject to the terms and conditions as specified in the NOFA, and the Standard Agreement provided by the Department after approval, the Application and any and all accompanying documents, which are incorporated in full as part of the Standard Agreement, and any and all activities funded, information provided, and timelines represented in the Application will be enforceable through the fully executed Standard Agreement; and

BE IT FURTHER RESOLVED by the Board of Supervisors of the County of San Benito that it hereby agrees that pursuant to the NOFA and in conjunction with the terms of the
